

## **CONSENT OF THE WEBSITE VISITOR TO THE PROCESSING OF PERSONAL DATA**

1. This Consent is given to the processing of my personal data, which is not special or biometric:
  - Full name;
  - Date and place of birth;
  - Passport data (if applicable);
  - Place and region of work;
  - Telephone number;
  - E-mail address;
  - Academic degree;
  - Title;
  - Place of work;
  - Position.
2. This Consent is given for the purpose of processing personal data, namely:
  - Identification of the user registered on the Website;
  - Providing the user with access to personalized resources of the Website;
  - Confirmation of the accuracy and completeness of personal data provided by the user;
  - Providing the user with technical support in the event of problems related to the use of the Website;
  - Communication with the user, including sending notifications, requests and information, as well as processing requests and applications from the user;
  - Conducting analytical research;
  - Creation of the base of the Website users;
  - Providing information about the Operator and its partners, the services of the Operator and its partners, the event, the organizer and / or technical partner of which is the Operator;
  - Organizing participation in events and surveys conducted by the Operator;
  - Responses to requests through the feedback form on the Website and to messages sent to the Operator's e-mail.
3. Processing (on paper; using automation tools and without using automation tools, as well as in a mixed way) by the Operator of my personal data must be carried out in accordance with the requirements of the Federal Law dated July 27, 2006 No. 152-FZ "On Personal Data", the Operator's Policy on the Processing and Protection of Personal Data.
4. This Consent is granted for the implementation of any action (operation) or a combination of actions (operations) with respect to personal data that are necessary and desirable for the achievement of the above goal, including, without limitation, collection, recording, arrangement,

systematization, accumulation, storage, specification (updating, modification), extraction, use, distribution (including transfer), anonymizing, blocking, destruction of personal data.

8. This Consent is valid all the time until the moment of its withdrawal, taking into account clauses 6 and 7 hereof.
